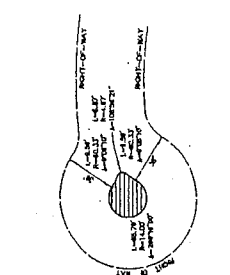
Reserve Area 'A' Detail



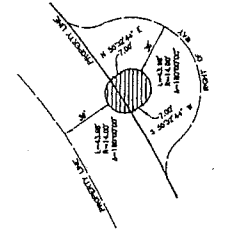
Reserve Area 'B' Detail
